**Report Highlights:**

On August 3, 2018, the Ministry of Finance (MOF) issued a notification delaying the implementation date of tariff increases on several U.S. agricultural products (i.e. shelled and in-shell almonds, in-shell walnuts, fresh apples, and pulses) by another 45 days until September 18, 2018.

## GOI Delays Implementation Date of Tariff Increases on U.S. Agricultural Products

On August 3, 2018, the Department of Revenue under the MOF issued notification [56/2018](#) that announced a 45-day delay, from August 4, 2018 to September 18, 2018, for tariff increases on certain U.S. agricultural imports to go into effect. If implemented, these tariff increases would apply only to U.S.-origin shelled and in-shell almonds, in-shell walnuts, apples, and pulses, and could give advantage to U.S. competitors and possibly result in a significant negative impact on U.S. exports to India.

On June 20, 2018, the MOF issued notifications [48/2018](#) and [49/2018](#) that announced tariff increases on certain U.S.-origin agricultural products, effective August 4.

G.S.R. (E).- In exercise of the powers conferred by sub-section (1) of section 25 of the Customs Act, 1962 (52 of 1962) and sub-section (12) of section 3 of the Customs Tariff Act, 1975 (51 of 1975), the Central Government, being satisfied that it is necessary in the public interest so to do, hereby makes the following further amendments in the notification of the Government of India, Ministry of Finance (Department of Revenue), No. 50/2017-Customs, dated the 30th June, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), *vide*, number G.S.R. 785(E), dated the 30th June, 2017, namely:-

In the said notification, with effect from the 4th day of August, 2018 the following proviso shall be inserted after the second proviso, namely:-

“Provided also that the.-

- (a) entries against serial number 14A, and
  - (b) the second proviso,
- shall come into effect from the 18<sup>th</sup> day of September, 2018”.
